

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the expenditure of \$500.00 be and it is hereby authorized from General Fund 100, Unallocated Reserve, solely and exclusively for a study, to be jointly funded by all thirteen (13) cities of San Diego County, of the feasibility of a regional approach to the management and administration of municipal liabilities, loss prevention, claims control and joint insurance purchasing. The City of Oceanside is the sponsoring agency, and has invoiced each of the thirteen (13) cities for its share (\$500.00) of the cost of the study.
