WHEREAS, the fiscal year 1977 budget includes the sum of \$3,300,000 in the General Fund Unallocated Reserve for a Special Litigation Liability Reserve for San Diego Gas & Electric Company litigation; and

WHEREAS, to preserve the funds, it is necessary to transfer that amount into a special trust fund where all interest earnings will be accumulated and credited to the liability account; and

WHEREAS, when the litigation is concluded and the amount of liability fixed, any funds remaining in said trust account will be returned to the General Fund for general municipal operations; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$3,300,000 from the General Fund 100, Special Litigation Liability Reserve (53.32) to a Special Litigation Liability Trust Fund (3024).
