

WHEREAS, the Pacific Beach Recreation Committee, formed to promote the programs of the Pacific Beach Recreation Center, as an act of civic generosity, has offered to contribute to The City of San Diego the sum of \$1,310 to assist the City in purchasing a Universal Gym needed for the Center; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


1. That the City Manager of The City of San Diego hereby accepts the generous contribution of \$1,310 from the Pacific Beach Recreation Committee and directs that said contribution be deposited in Capital Outlay Fund 245 and thereafter be matched by an additional \$1,310 from The City of San Diego to be used exclusively for the purpose of purchasing a Universal Gym for the Pacific Beach Recreation Center.

2. That the expenditure of \$1,310 from the Capital Outlay Fund 245 is hereby authorized solely and exclusively for the purchase and installation of a Universal Gym for the Pacific Beach Recreation Center.

3. That this Council does hereby commend the Pacific Beach Recreation Committee for this act of civic generosity and does hereby publicly express on behalf of the citizens of this City a debt of gratitude to the Pacific Beach Recreation Committee.
