WHEREAS, the San Diego Regional Employment and Training Consortium (RETC) anticipates receiving 12-14 million dollars pursuant to the supplemental Title VI PSE allocation; and

WHEREAS, certain worthwhile local projects exist that greatly benefit the residents of the City of San Diego but because of jurisdictional limitations must be implemented by governmental entities not a part of the City,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

The City of San Diego endorses and strongly recommends that the following designated public agencies utilize the resources of CETA Special Projects funding to seek approval for specified public projects of mutual concern to all:

1. San Diego Unified Port District - Relocation of Harbor Drive at Navy Field.
2. State of California Department of Transportation - Widening of Interstate 15 at Mira Mesa - Mira Mar area.
3. State of California, Department of Forestry - Brush Clearance in San Diego County.
4. County of San Diego Department of Health - Cardiovascular-Pulmonary resuscitation training.
