WHEREAS, the subject of revising the fee schedule for Mission Bay moorings and beach bars has been discussed by the Public Facilities and Recreation Committee of the City Council; and

WHEREAS, the City Council proposes to adopt the City Manager's recommended fee schedule for Mission Bay moorings and beach bars with the understanding that said fees are to be viewed as discounting the fair market value; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That Resolution No. 200007, adopted June 11, 1970 by the Council of The City of San Diego, is hereby rescinded.

BE IT FURTHER RESOLVED, that the following schedule of mooring and beach bar fees for Mission Bay, recommended pursuant to Section 63.25.3(e) of the San Diego Municipal Code and approved by the City Manager, be and the same is hereby approved:
