BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the following schedule of fees for towing and impound charges for Mission Bay, recommended pursuant to Section 63.25.3(e) of the San Diego Municipal Code and approved by the City Manager, be and the same is hereby approved:

<u>Subject</u>	<u>Fee</u>
a. Towing Derelicts Nonemergency Towing Within the Bay	\$7.50 all vessels.
b. Impound Charges	\$2.00 per day.

BE IT FURTHER RESOLVED, that the City Manager may waive any of the fees contained in the schedule listed above arising out of the participation of any boat in a regularly scheduled regional or national race, meeting or other competitive event in Mission Bay.
