

RESOLUTION No. 217881 (R-77-1544)


Adopted on MAR 9 1977

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the Department of Legislative Representation be, and it is hereby directed to take all necessary actions to seek appropriate State legislation to amend the California Public Resources Code to revise certain historical site procedures, including the requirement that all applications for listing in the National Register of Historic Places shall only be considered by the State Historic Preservation Officer after a historical site board makes a recommendation on the applications.
