

RESOLUTION NO. 217887 MAR 9 1977

VACATION OF GRANITO COURT AND JARDIN COURT IN
GENESEE HIGHLANDS UNIT NO. 1.

WHEREAS, it is proposed that Granito Court and Jardin Court
be vacated; and

WHEREAS, the streets were dedicated at no cost to the public
in 1972 and have remained unimproved and there is no present or
prospective use for the streets, either for the public street
system for which the rights-of-way were originally acquired or
for any other public use of a like nature that can be anticipated;
and

WHEREAS, the public will benefit from the vacation through
improved utilization of land; and

WHEREAS, the vacation or abandonment is not inconsistent
with the General Plan or an approved Community Plan; and

WHEREAS, the public street system for which the rights-of-way
were originally acquired will not be detrimentally affected by
this vacation as it has been deemed excess by City staff pursuant
to Council Policy 600-15; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
California, that GRANITO COURT and JARDIN COURT, as more parti-
cularly referred to in Resolution of Intention No. 217629
is unnecessary for present or prospective public street purposes.

BE IT FURTHER RESOLVED, that GRANITO COURT and JARDIN COURT
as more particularly shown on Map No. 13829-B on file in the

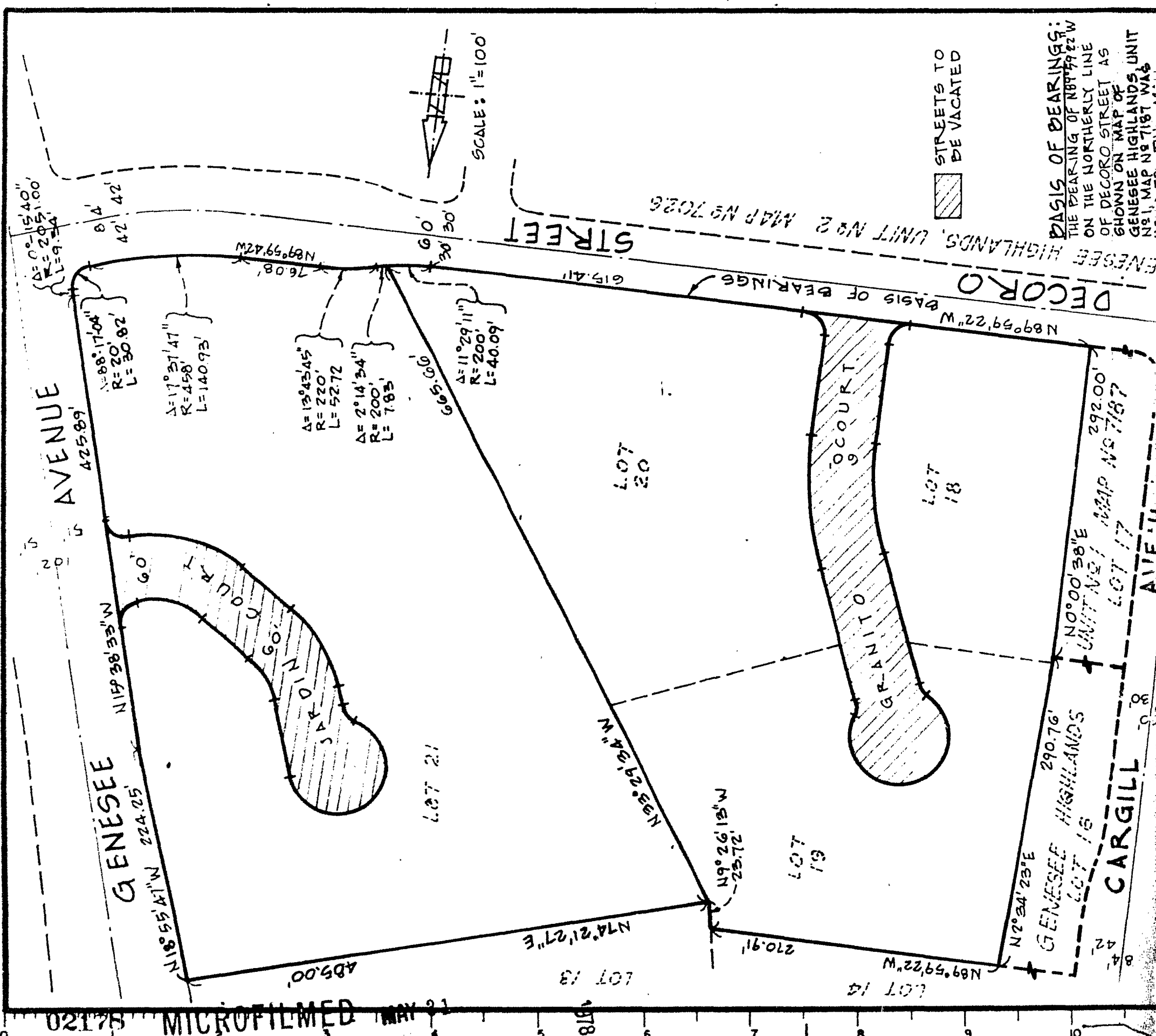

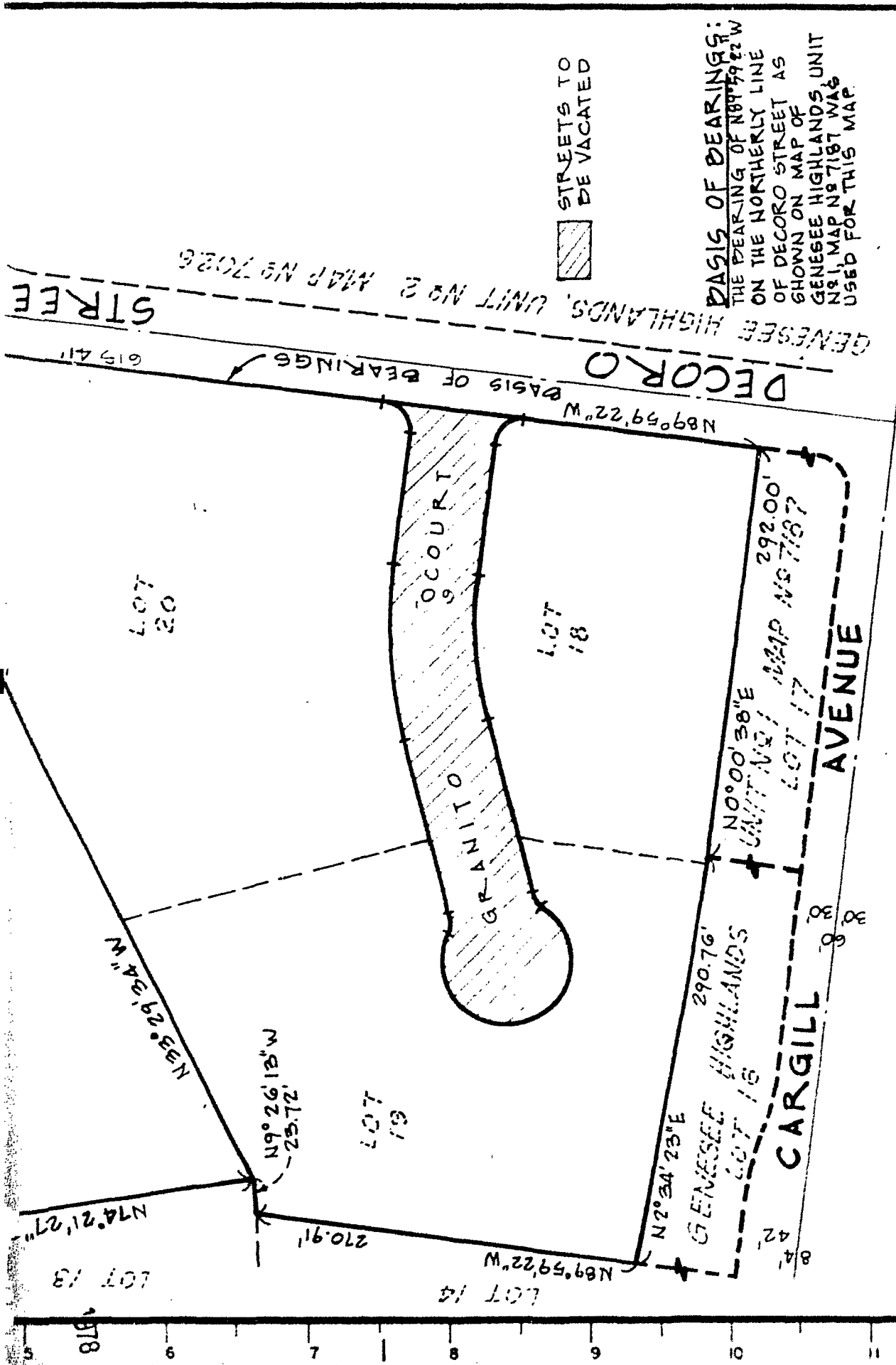
