

RESOLUTION NO. 217888 MAR 9 1977

VACATION OF A PORTION OF KALE STREET, ADJACENT TO WHAT WAS KNOWN AS THE "DEPOT GROUNDS" ON SORRENTO LANDS AND TOWNSITE, MAPS 362 AND 483, VACATED BY SCC 87450, NOW PART OF PUEBLO LOTS 1357 AND 1359.

WHEREAS, it is proposed that a portion of KALE STREET be vacated; and

WHEREAS, the street was dedicated at no cost to the public in 1888 and has remained unimproved and there is no present or prospective use for the street, either for the public street system for which the right-of-way was originally acquired or for any other public use of a like nature that can be anticipated; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation or abandonment is not inconsistent with the General Plan or an approved Community Plan; and

WHEREAS, the public street system for which the right-of-way was originally acquired will not be detrimentally affected by this vacation as it has been deemed excess by City staff pursuant to Council Policy 600-15; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, California, that a portion of KALE STREET, adjacent to what was known as the "Depot Grounds" on Sorrento Lands and Townsite, Maps 362 and 483, vacated by SCC 87450, now part of Pueblo Lots 1357 and 1359, as more particularly referred to in Resolution of Intention No. 217630 is unnecessary for present or prospective public street purposes.



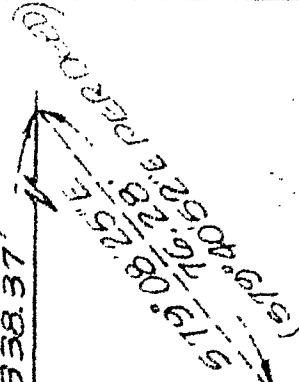
