WHEREAS, the public street system for which the right-of-way was originally acquired will not be detrimentally affected by this vacation as it has been deemed excess by City staff pursuant to Council Policy 600-15; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
California, that a portion of KALE STREET, adjacent to what was
known as the "Depot Grounds" on Sorrento Lands and Townsite,
Maps 362 and 483, vacated by SCC 87450, now part of Pueblo Lots
1357 and 1359, as more particularly referred to in Resolution
of Intention No.

217630 is unnecessary for present or
prospective public street purposes.


