WHEREAS, the appeal of George M. Amancio from the decision of the City Engineer in requiring under Application 7605 the paving of a portion of an alley pursuant to Section 62.0207 of the San Diego Municipal Code in connection with an application for a building permit on Lot 16, Block 189, University Heights, came on regularly for hearing at the Council meeting of March 15, 1977; and

WHEREAS, the Council determined that the public interest would best be served by the initiation by the City of a 1911 Act Street Improvement proceeding to pave the entire alley; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City hereby initiate a 1911 Act Street Improvement proceeding to pave the entire alley abutting for a part of its length Lot 16, Block 189, University Heights.
