WHEREAS, Coupon No. 18 from City of San Diego 1966 Sewer Revenue Bonds, Series B, 5.1%, due May 1, 1995, from Bond No. 1388, due November 1, 1977, cannot be found or produced; and

WHEREAS, a request has been received to pay \$127.50 in lieu of issuance of a coupon to replace that one lost; and

WHEREAS, an indemnity bond has also been received to indemnify the City for possible loss due to making such payment;
NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Treasurer is hereby authorized to pay the sum of \$127.50 to Davis, Skaggs & Co., Inc., San Francisco, in lieu of issuance of one coupon to replace coupon (No. 18) due November 1, 1977, which was lost, mislaid, destroyed or stolen, from Bond No. 1388, City of San Diego 1966 Sewer Revenue Bonds.

BE IT FURTHER RESOLVED, that the City Treasurer place in the City Treasurer's files the Indemnity Bond from Insurance Company of North America dated February 3, 1977, which indemnifies the City from possible loss due to making payment for such lost coupon.
