BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the CALIFORNIA WHEELCHAIR ASSOCIATION, INC., a California nonprofit corporation, for the purpose of promoting and conducting the 1977 California Wheelchair Games during the period May 19 to May 22, 1977, pursuant to the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 758671.

BE IT FURTHER RESOLVED, that the provisions of Council Policy No. 100-3 relating to the prohibition of building up of reserves and paragraph B.1. relating to bona fide community organization be and they are hereby waived.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to transfer within the 224 Fund the sum of \$4,000 from the Unallocated Reserve (52.99) to the California Wheelchair Association (52.25) to be used solely and exclusively for the above purpose.
