BE IT RESOLVED, by the Council of The City of San Diego as follows:



BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$12,800.00 from CDBG Fund 290, Element 87.90, for services rendered pursuant to the above agreement is hereby authorized and approved.
