

RESOLUTION NO. 217933 March 16, 1977

RESOLUTION OF THE COUNCIL OF THE CITY
OF SAN DIEGO, ORDERING CHANGES IN THE
REPORT.

(La Jolla Scenic Drive and Via Capri Assessment District)

WHEREAS, in proceedings under the Municipal Improvement Act of 1913 (commencing with Section 10000, Streets and Highways Code) the Council adopted resolution of intention, Resolution No. 217393, ordering the Superintendent of Streets to prepare the Report required by that Act and providing for a contribution of \$128,780.22 by the city and a contribution of \$75,853.65 by The Regents of the University of California; and

WHEREAS, pursuant to the resolution of intention the Superintendent of Streets prepared the Report, including the four parts submitted with and made a part of the Report, said parts consisting of plans and specifications showing and describing the proposed acquisitions and improvements, an estimate showing the costs and expenses of the improvements and contributions by the city and the Board of Regents, a proposed diagram showing the assessment district, and a proposed assessment of the costs and expenses of the proposed acquisitions and improvements, the Report being on file with the City Clerk; and

WHEREAS, the Council adopted Resolution No. 217394 approving the Report, as filed, and appointing a time and place of hearing thereon; and

WHEREAS, the Council is of the opinion that, prior to the conclusion of the hearing, a change should be made in the diagram to show Avenue of Stars, an existing dedicated street, with a corresponding reduction in the assessable area of the assessment parcel within which the street is located, and that, by reason of the lowest responsible construction bid being less than the estimated construction costs shown in the Report, reductions should be made in the amounts of the contributions made by the city and the Board of Regents and also in the amounts of all individual assessments; and

WHEREAS, the Superintendent of Streets has prepared and submitted a "Schedule of Changes" showing and describing all such changes; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Section 1. The "Schedule of Changes" of the Superintendent of Streets, attached hereto and made a part hereof, is approved and those parts of the Report referred to in the




Schedule of Changes
