
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the expenditure of \$117,225.11 from Gas Tax Fund 220, including \$35,000.11 from those funds previously authorized pursuant to Resolutions Nos. 206392 and 216139, is hereby authorized solely and exclusively for the purpose of providing funds for the City's contribution for the improvement of LA JOLLA SCENIC DRIVE BETWEEN SOLEDAD MOUNTAIN ROAD AND VIA CAPRI AND VIA CAPRI BETWEEN LA JOLLA SCENIC DRIVE AND CHATEAU VILLA SUBDIVISION, as more particularly described in Resolution of Intention No. 217393 and pursuant to the Municipal Improvements Act of 1913.

BE IT FURTHER RESOLVED, that the expenditure of \$39,075 from Capital Outlay Fund 245 is hereby authorized solely and exclusively for the purpose of reimbursing Capital Outlay Fund 56.50, Engineering for Capital Improvement Program Projects, for the unrecoverable cost of engineering and administrative services for said improvement.
