

RESOLUTION No. 217936 (R-77-1583)

Adopted on March 16, 1977


BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized to accept, for and on behalf of said City, the sum of \$75,330.48 from the Regents of the University of California as the University's contribution to the LA JOLLA SCENIC DRIVE AND VIA CAPRI ASSESSMENT DISTRICT, and the SOLEDAD MOUNTAIN WATER PUMPING PLANT ASSESSMENT DISTRICT.

BE IT FURTHER RESOLVED, that the expenditure of \$68,374.48 is hereby authorized as a contribution by the University in lieu of an assessment for the LA JOLLA SCENIC DRIVE AND VIA CAPRI ASSESSMENT DISTRICT improvements (Fund 3721), and that \$6,956.00 is to be deposited in the 3021 Trust Fund to be used solely and exclusively for payment against the future assessment on behalf of the University for the SOLEDAD MOUNTAIN WATER PUMPING PLANT ASSESSMENT DISTRICT improvements.
