RESOLUTION OF THE COUNCIL OF THE CITY  
OF SAN DIEGO, CALIFORNIA, AMENDING  
RESOLUTIONS NOS. 217395 AND 217633  
DIRECTING THE CITY CLERK TO GIVE NOTICE  
INVITING SEALED BIDS FOR THE PURCHASE  
OF IMPROVEMENT BONDS.

(La Jolla Scenic Drive and Via Capri Assessment District)

WHEREAS, the Council adopted Resolution No. 217395 directing the City Clerk to give notice inviting bids for the purchase of bonds to be received up to 11:00 A.M. on March 7, 1977 and adopted Resolution No. 217633 amending Resolution No. 217395 to provide for bond bid opening at 11:00 A.M. on April 4, 1977; and

WHEREAS, from time to time the Council has continued the hearing on the project and the formation of the assessment district and deems it advisable to further change the date for the receipt and opening of bids for the purchase of bonds; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

Section 1. In lieu of the times specified in Resolutions Nos. 217395 and 217633, the form of notice inviting bids for the purchase of improvement bonds, as set forth in Section 2 of Resolution No. 217395, under the caption "TIME AND PLACE FOR


