
Adopted on MAR 16 1977

That the appeal of Charles M. Maddox dba A. A. Auto Parts, from the decision of the Old San Diego Planned District Review Board, which Board denied his application, under Case No. 7560, to maintain an existing pole sign at 4285 Taylor Street, in the Old San Diego Planned District, is denied, and the decision of the Old San Diego Planned District Review Board is affirmed.

BE IT FURTHER RESOLVED, that the City Council hereby finds that the subject pole sign does not comply with the requirements applicable to the Old San Diego Planned District in that the sign placement, the sign size and the sign materials are all in violation of said regulations.
