

RESOLUTION NO. **217945**

WHEREAS, the Pomerado County Water District has a present capacity right of 2.0 MGD (million gallons per day) in the Metropolitan Sewerage System; and

WHEREAS, the Metropolitan Sewerage System is approaching in daily use its rated capacity; and

WHEREAS, there are member agencies in the Metropolitan Sewerage System who have purchased capacity rights which, if used, would result in the average daily flow exceeding the rated capacity of the treatment plant; and

WHEREAS, extensive studies are presently being conducted which will be used in determining the design and location of future Metropolitan sewer treatment facilities; and

WHEREAS, the Federal Congress is currently considering legislation which could impact the Metropolitan Sewerage System's ability to accommodate growth in the San Diego area; and

WHEREAS, the Pomerado County Water District has requested additional capacity; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the County of San Diego is hereby requested not to issue any additional building permits in the Pomerado County Water District service area unless the County is legally required so to do.

2. That upon the establishment by the County of the above suggested moratorium, the City will provide additional sewage

capacity to Pomerado County Water District to serve the areas presently being served in the Poway area. The capacity to be provided would be that required in the south basin to meet existing flows plus building permits already issued plus building permits which legally must be issued plus an allowance for failing septic tanks. This capacity will be provided in the Penasquitos-Metropolitan Sewerage System. Capacity will also be provided in the north basin under the same conditions with capacity to be provided in the Rancho Bernardo-Escondido-San Elijo Outfall System.

3. That the City Manager is authorized to negotiate agreements with the Pomerado County Water District to provide the required capacity.

4. That the building moratorium remain in effect until The City of San Diego and the County of San Diego have formulated a mutually agreeable growth management plan, at which time the above conditions will be reevaluated.
