

BE IT RESOLVED, by the Council of The City of San Diego as follows:

R77-1638

1. That the bid of \$26,968.40 by Henry L. Foster, an individual dba H. L. Foster Construction Company for the CONSTRUCTION OF PEDESTRIAN RAMPS FOR THE HANDICAPPED - CONTRACT NO. 4 in the City of San Diego, California is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 757630.
2. That the expenditure of \$32,425.00 is hereby authorized out of the Second Year Block Grant Fund (Fund 290); that the expenditure of \$3,075.00 is hereby authorized out of the Capital Outlay Fund (Fund 245) of the City of San Diego solely and exclusively for the purpose of providing funds for the CONSTRUCTION OF PEDESTRIAN RAMPS FOR THE HANDICAPPED - CONTRACT NO. 4 in the City of San Diego, and related costs.
