

RESOLUTION NO. 217955

APPROVING MAP OF MARKET STREET INDUSTRIAL PARK

BE IT RESOLVED, by the Council of the City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by DON NASLAND, a Licensed Land Surveyor, entitled "MARKET STREET INDUSTRIAL PARK Being a subdivision of a portion of Lot 36 of Ex-Mission Lands (commonly called Horton's Purchase), in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 283, filed in the office of the County Recorder of San Diego County, March 9, 1878." is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Raven Street, Lockridge Street, Whitman Street, a portion of Market Street and a portion of 41st Street for public purposes; and said streets and portions of streets are hereby declared to be public streets and portions of public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to 41st Street, adjacent and contiguous to Lots 4, 5 and 6, all as shown on this map within this subdivision and subject to the conditions set forth thereon.



The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and portions of public streets are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access, together with the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
