

RESOLUTION NO. 217968 (R. 77-1606)

MAR 23 1977

WHEREAS, The City of San Diego is the Lessor of that portion of Pueblo Lot 206 of the Pueblo Lands of San Diego, according to the Map thereof made by James Pascoe in 1870, a copy of which was filed in the Office of the County Recorder of San Diego County, November 14, 1921, and is known as Miscellaneous Map No. 36; described in a Deed recorded January 28, 1916 in Book 12, Page 423 of Patents, records of said County of San Diego; and

WHEREAS, the San Diego Gas & Electric Company, a corporation, has requested the conveyance of an easement for the purpose of underground electrical facilities across said property to provide electrical service to the Young Men's Christian Association of San Diego and San Diego County, a California nonprofit corporation; and

WHEREAS, the purpose for which the easement is required is a public purpose; and


WHEREAS, the City Manager, pursuant to Section 22.0907 of the San Diego Municipal Code, has recommended that said easement be conveyed to the San Diego Gas & Electric Company, a corporation;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That, in consideration of the benefits to accrue to the people of said City, the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a deed conveying to the SAN DIEGO GAS & ELECTRIC COMPANY, a corporation, an easement for the purpose of underground electrical facilities across a portion of Pueblo Lot 206, as more particularly described in the form of deed on file in the Office of the City Clerk as Document No. 758752.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
