BE IT RESOLVED, by the Council of The City of San Diego as follows:


That the acceptance by the City Manager of an alley easement deed of JOE C. CORREIA and ETHEL VIVIAN CORREIA, husband and wife, executed in favor of The City of San Diego, bearing date of January 26, 1977, conveying to said City the following described property:

The easterly 2.50 feet of the south 1/3 of Lot 1 of PALM HEIGHTS, according to the Map thereof No. 1023 filed in the office of the County Recorder of San Diego County, TOGETHER with the easterly 2.50 feet of Lot 1 of IDYLLWILD, according to the Map thereof No. 998 filed in said County Recorder's Office;

for the widening of the existing alley by 2.50 feet as required by City Permit Application 7330-2, be and is hereby approved, and said property is hereby dedicated as a public alley.

That the City Clerk is hereby authorized and directed to file said deed, after acceptance by the City Manager, and a certified copy of this resolution for record in the office of the San Diego County Recorder.
