
BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Pursuant to Section 72.0110 of the San Diego Municipal Code, the City Council establishes the following minimum insurance requirements for the operation of taxicabs in the City of San Diego:

- (1) \$100,000/\$300,000 personal injury, \$50,000 property damage with a \$1,000 deductible allowable if approved by insurance carrier.

BE IT FURTHER RESOLVED, that this resolution becomes effective on the same date upon which Ordinance No. 12051 N.S., which amends Section 72.0110 of the San Diego Municipal Code, becomes effective.
