That said Council approves in concept a program for conveyance, for park purposes, of land lying within Penasquitos Canyon phased with the development of property under the ownership of Penasquitos, Inc., and described in detail in the Engineering and Development Department's Report to Council entitled "Los Penasquitos Park;" and directs that an agreement be prepared which provides that all development of areas addressed by the Penasquitos, Inc. master plan shall be subject to the provisions of applicable community plans as finalized by Council action.
