BE IT RESOLVED, by the Council of The City of San Diego,
as follows:


Said Council hereby finds that that certain map surveyed by CHARLES W. CHRISTENSEN, a Registered Civil Engineer, entitled "G-W PLANNED INDUSTRIAL DEVELOPMENT Being a subdivision of Lots 8, 9, 10 and 11 of G-W Industrial Park Unit No. 3, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 8190, filed in the office of the County Recorder of San Diego County, October 23, 1975.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer and water facilities as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map, and that those certain easements for sewer and water facilities, as granted and shown on this map, are accepted on behalf of The City of San Diego, as above stated.

said map to the Clerk of the Board of Supervisors of the
County of San Diego, California.
