Virginia R. Edwards	Treasurer	\$25 <sub>.</sub>	Ms. Edwards is a Senior Clerk in the Treasurer's Office. She sug- gested that improvement bonds be perforated to reduce the time necessary to hand clip them. This idea saves the City an estimated \$255 in the first year of operation
Flavian R. Geis	Engineering & Development	\$25	Mr. Geis is an Intermediate Typist. He suggested that each location of his department keep a running list of the inventory of office equipment. Although this requires a little more effort throughout the year, it reduces the cost of yearly inventory by \$228 in time savings.
Ted Myrus	General Services	\$15	Mr. Myrus is an Equipment Mechanic in the Equipment Division. He suggested that packers be equipped with additional stop/turn indicators on top of the refuse container. No savings are expected, but the safety of operating these vehicles is improved.
