
BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the expenditure of not to exceed \$50,000 (from environmental Growth Fund 2505), to be combined with the amount of not less than \$50,000 bequeathed to the City from the estate of Dewitt K. Friday, for the purpose of purchasing a 0.516 acre open space site on the south side of Pringle Street between Guy and Puterbaugh Streets and retaining the site in public ownership as an Open Space Park, is hereby authorized.

2. That the City Manager is hereby authorized and directed to take appropriate steps towards obtaining an option to purchase said property.

3. That the City Auditor is hereby authorized and directed to establish a Trust Fund into which public donations to supplement the City funds and the Friday Estate funds may be deposited and from which expenditures may be authorized for the acquisition of said property.
