

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$369,827.17 by Floyd R. Stanfield, an individual dba F. R. Stanfield Company for the CONSTRUCTION OF SEWER AND WATER GROUP 34 - LA JOLLA AREA in the City of San Diego, California is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 757857.
2. That the expenditure of \$362,000.00 is hereby authorized out of the Sewer Revenue Fund (Fund 506), and that the expenditure of \$105,000.00 is hereby authorized out of the Water Revenue Fund (Fund 502) of the City of San Diego solely and exclusively for the purpose of providing funds for the CONSTRUCTION OF SEWER AND WATER GROUP 34 - LA JOLLA AREA in the City of San Diego, and related costs.
