

RESOLUTION No. 218010

(R-77-1696)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. Neptune Water Meter Company, Subsidiary of Neptune International Corp., 2. Carlon Meter Company, 3. Rockwell International Corporation, 4. Gamon-Calmet Industries, 5. Hersey Products Inc., 6. Badger Meter, Inc., and 7. Muesco, Inc., Measurement & Control Division, are hereby accepted, and the City Manager is hereby authorized to execute contracts for the purchase of WATER METERS AND PARTS as may be required for a period of one (1) year beginning March 1, 1977 through February 28, 1978, per prices on file in the office of the City Purchasing Agent as follows:

1. Neptune Water Meter Company, Subsidiary of Neptune International Corp., for Items 1, 2, and 3 of Section I and for parts for all Neptune Meters (Section II), plus sales tax, terms net 30 days, with an option to renew for an additional year at the same prices and terms,
2. Carlon Meter Company for Items 4 and 6 of Section I and for parts for all Carlon Meters (Section II), plus sales tax, terms net 30 days, with an option to renew for an additional year at the same prices and terms,
3. Rockwell International Corporation for Item 5 of Section I and for parts for all Rockwell Meters (Section II), plus sales tax, terms net 30 days, with an option to renew for an additional year at prices subject to an escalation not to exceed 5% of bid prices,
4. Gamon-Calmet Industries for parts for all Gamon-Calmet Meters (Section II), plus sales tax, terms net 30 days,
5. Hersey Products Inc. for parts for all Hersey Meters (Section II), plus sales tax, terms net 30 days,
6. Badger Meter, Inc. for parts for all Badger Meters (Section II), plus sales tax, terms net 30 days, with an option to renew for an additional year at the same prices and terms, and
7. Muesco, Inc., Measurement & Control Division, for parts for various brands of meters (Section II), plus sales tax, terms net 30 days, with an option to renew for an additional year at the same prices and terms.
