
Adopted on MAR 30 1977

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$26,441.00 by Gary C. Gandy, an individual dba Addax Construction Company, for the improvement of HENDRIX PARK, in the City of San Diego, is hereby accepted; and the City Manager is hereby authorized and empowered to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 757949.

2. That the amount of \$4,317.56 previously authorized in Resolution No. 215508, adopted March 10, 1976, which provided an estimated six-month maintenance cost of the HENDRIX PARK improvements, is declared to no longer be needed for that purpose and said funds are hereby authorized to be utilized solely and exclusively for the purpose of providing funds for the above-referenced contract for improvements.
