

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City of San Diego's representatives to the Regional Employment and Training Consortium (RETC) be, and they are hereby authorized and empowered to submit those projects to RETC that have been classified as "A," "B" and "C" as set forth in the document attached hereto as Exhibit 1 for purposes of the supplemental Title VI PSE allocation.

BE IT FURTHER RESOLVED, that said representatives are authorized to endorse and recommend to RETC that the brush clearance program and widening of Interstate 15 at Mira Mesa-Miramar area program as set forth in Resolution No. 217854 be additionally funded pursuant to the supplemental Title VI PSE allocation.
