WHEREAS, the San Diego Asebring Association is planning to hold an Auto Cross at the Stadium parking lot on June 4 and June 5, 1977; and

WHEREAS, an Auto Cross is a single-car skilled driver event-not a race that would create a noise problem--and all proceeds from this event would be directed to the Cystic Fibrosis Foundation; and

WHEREAS, the Cystic Fibrosis Foundation has requested the City Council to waive the \$600 fee for the use of the San Diego Stadium parking lot on June 4 and 5, 1977; and

WHEREAS, since the Stadium Joint Powers Agreement precludes free use of the San Diego Stadium, this resolution would pay the rental fee of \$600 from the Unallocated Reserve; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Auditor and Comptroller be and he is hereby authorized to transfer \$600 from the General Fund 100, Unallocated Reserve (53.30) to the San Diego Stadium Operations Fund 256, solely and exclusively for the purpose of providing funds for the rental fee for use of the Stadium parking lot on June 4 and June 5, 1977, by the San Diego Asebring Association, said payment of fee by the association having been waived by the Council.
