That pursuant to the provisions of California Public Resources Code Section 21081 and in connection with Environmental Impact Report No. 76-10-09P, all land fill material necessary for any development of a subdivision on the property rezoned by draft Ordinance 0-77-185 shall not be taken from the property within the adjacent property presently under the same ownership and located within the floodway zone adjacent to this area and these are deemed and determined to be appropriate findings of mitigation in connection with said Environmental Impact Report.
