BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$115,306.22 by Traho Corporation, a corporation, for the CONSTRUCTION OF SWITZER CHANNEL BULKHEAD AND SEDIMENTATION BASIN in the City of San Diego, California, is hereby accepted; and that the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 757764.
2. That the expenditure of \$144,500.00 is hereby authorized out of the Flood Control and Storm Drain Bond Fund (Fund 727) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF SWITZER CHANNEL BULKHEAD AND SEDIMENTATION BASIN in the City of San Diego, and related costs.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$69,000.00 from CIP 11-080 to the Flood Control and Storm Drain Bond Fund (Fund 727) Reserve CIP 90-727.
