



BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$18,614.00 by Herman Thompson dba Thompson Construction, for the RECONSTRUCTION OF CURB AND SIDEWALK IN THE AREA BOUNDED BY WABASH BOULEVARD, GILLETTE STREET, IMPERIAL AVENUE, 40TH STREET, FRANKLIN AVENUE, 38TH STREET AND OCEAN VIEW BOULEVARD PHASE III (Base Bid) in the City of San Diego, California is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 758124.
2. That the expenditure of \$26,600.00 is hereby authorized out of the Capital Outlay Fund (Fund 245) of the City of San Diego solely and exclusively for the purpose of providing funds for the RECONSTRUCTION OF CURB AND SIDEWALK IN THE AREA BOUNDED BY WABASH BOULEVARD, GILLETTE STREET, IMPERIAL AVENUE, 40TH STREET, FRANKLIN AVENUE, 38TH STREET AND OCEAN VIEW BOULEVARD PHASE III (Base Bid) in the City of San Diego, and related costs.
