

RESOLUTION NO. 218075 (R. 77-1812)

WHEREAS, the map of GATEWAY ESTATES RESUBDIVISION, adopted on this date, dedicates a new alignment for a street named CAITHNESS DRIVE; and

WHEREAS, this alignment of CAITHNESS DRIVE proposed by the map of GATEWAY ESTATES RESUBDIVISION intersects with ATHEY DRIVE; and

WHEREAS, the Planning Commission has reviewed and approved the development and the alignment of the proposed CAITHNESS DRIVE, and the location of said intersection; and

WHEREAS, it appears to be in the public interest to change the names of those aforesaid portions of ATHEY AVENUE; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego as follows:

1. A portion of ATHEY AVENUE be renamed CAITHNESS DRIVE; as more particularly shown on Drawing No. 13912-B on file in the office of the City Clerk as Document No. 758880, which said drawing is made a part hereof; and

BE IT FURTHER RESOLVED, that the City Clerk of said City be and is hereby directed to file a certified copy of this resolution in the office of the County Recorder and the County Surveyor of San Diego County.
