WHEREAS, a certain drainage easement was acquired for earlier development in the area now included within, and adjacent to, the subdivision now known as Penasquitos Bluffs, Unit No. 7; and

WHEREAS, the present development of the affected property requires realignment of certain existing facilities; and

WHEREAS, these aforementioned facilities no longer serve the purpose for which they were originally constructed; and

WHEREAS, the present easement alignment will conflict with the new layout and street alignment; and

WHEREAS, the City will receive substitute easements where required as granted on the subdivision map of the subdivision known as Penasquitos Bluffs, Unit No. 7; and


WHEREAS, with the approval of the subdivision map of Penasquitos Bluffs, Unit No. 7, the City will no longer have any need for said easement and the City Manager has recommended that the City abandon its interest therein; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the City of San Diego by this resolution does hereby abandon whatever right, title or interest it may have in that drainage easement as more particularly shown on Drawing 13753-B on file in the office of the City Clerk as Document No. 758898, is by this reference incorporated herein and made a part hereof be, and the same is hereby ordered abandoned.

2. That the City Clerk shall cause a certified copy of this resolution, with drawings, attested by him under seal, to be recorded in the office of the County Recorder.
