BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the petition for the construction of certain improvements in the ALLEY, BLOCK 36, WHITNEY ADDITION (between Main Street and Boston Avenue, 31st Street and 32nd Street), under the provisions of the Improvement Act of 1911, consisting of one sheet and filed under Document No. 758915, is hereby granted.

BE IT FURTHER RESOLVED, that the City Manager be, and he is hereby directed to prepare plans, drawings, typical cross-sections, profiles and specifications for the improvement of the unimproved portion of ALLEY, BLOCK 36, WHITNEY ADDITION (between Main Street and Boston Avenue, 31st Street and 32nd Street), in the City of San Diego, by the grading and paving as an alley section, together with estimates of the costs and expenses of such work and to furnish this Council with a description of the district to be included in the assessment for the work and improvements hereinabove mentioned.
