

RESOLUTION No. 218103 R. 77-1690

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to do by City forces all the work for the construction of drainage improvements to the tennis courts at Point Loma Park and Recreation Center, pursuant to the recommendation of the City Manager and submission of estimates by him indicating that said work can be done by the City forces more economically than if let by contract.

BE IT FURTHER RESOLVED, that the expenditure of \$5,000 is hereby authorized from Capital Outlay Fund 245, C.I.P. No. 20-001(7), and that the expenditure of \$2,307 is hereby authorized from Building Permit Park Fee Fund No. 17550, solely and exclusively for the purpose of providing funds for the drainage improvements described above.
