WHEREAS, The Civil Service Commission, pursuant to Charter Section 117(a)(15), voted unanimously to exempt this position from the classified service for a trial period of one year; and

WHEREAS, if Council concurs with this request, at the end of the year a decision will be made whether to continue the position as a classified position under the Civil Service System or discontinue it entirely; and

WHEREAS, the City Manager recommends promulgation and execution of an agreement with Norman H. Stamper for such services during this one year test program; and

WHEREAS, funds are available from salary savings for the remainder of fiscal year 1977, it being the intent of the Manager to address the remaining program expenses in the Police Department's Fiscal 1978 "Needs" Budget request; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be and he is hereby fully authorized to promulgate and execute, for and on behalf of said City, an agreement with Norman H. Stamper for consulting services as an Organizational Development Specialist, for the period April 25, 1977 through April 24, 1978, pursuant to the information set forth in the City Manager's report to the Mayor and Council dated March 18, 1977, and to the terms and conditions contained in the form of agreement on file in the office of the City Clerk as Document No.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be authorized to expend for this program a sum not to exceed \$32,797 for the remainder of fiscal year 1977.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby directed to make provision for additional expenses associated with this program in the Police Department's Fiscal 1978 "Needs" Budget request.

BE IT FURTHER RESOLVED, that the provisions of Council Policy 300-7 be and they are hereby waived.
