
BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a first amendment to agreement with BRIAN PAUL & ASSOCIATES, A.I.A., by amending the agreement filed as Document No. 749421 for design and construction of fire stations under the terms and conditions set forth in the form of first amendment to agreement on file in the office of the City Clerk as Document No. 758932.

2. That the expenditure of a sum not to exceed \$40,000 previously authorized by Resolution No. 212057 is hereby supplemented with an additional sum of \$12,650 and the expenditure of a sum not to exceed \$52,650 be and it is hereby authorized out of Capital Outlay Fund 245 of The City of San Diego for the aforementioned design and construction services and related project costs.
