WHEREAS, the location of any new prison facility affecting the City of San Diego should be approved only after public hearings have been held within the community; and


WHEREAS, the State of California should perform a site selection analysis for any new prison facility affecting the City of San Diego, which clearly indicates alternative sites considered and justifications for the site selected; and

WHEREAS, the State of California has indicated its intention to construct a new prison facility on Otay Mesa affecting the City of San Diego without conducting public hearings or without providing a site selection analysis clearly indicating alternative sites considered and justifications for the site selected at Otay Mesa; NOW, THEREFORE,

BE IT RESOLVED by the City Council of The City of San Diego that the City's Legislative Representative is hereby directed to actively oppose any executive action approving or any legislation or appropriation of monies for the State of California Department of Corrections' proposed prison on Otay Mesa; and

BE IT FURTHER RESOLVED that the City Council urges the State of California Department of Corrections to initiate immediately a site selection analysis of the proposed prison site, including a search for and analysis of other alternative sites in the State of California.
