

RESOLUTION NO. 218118 R. 77-1923

WHEREAS, the Comprehensive Planning Organization (CPO) is considering a draft Final Report of San Diego Plan for Air Transportation; and

WHEREAS, the draft Report omits certain essential data and is based on assumptions that are not in accord with currently known facts; and

WHEREAS, noise from jet-propelled airplanes awakens residents from their sleep at night and otherwise disturbs and injures residents of the City; and

WHEREAS, the City Council desires to obtain for residents of the City of San Diego as much relief from airplane noise as possible; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the position of the City of San Diego with respect to said draft Final Report dated December 1976 of the San Diego Plan for Air Transportation, prepared for the CPO by Daniel, Mann, Johnson and Mendenhall, is as follows:

1. That the CPO should reject said draft Report and not consider it for acceptance until certain essential data on noise, total expenditures, and sources of funds are supplied, and until certain assumptions as to costs of real estate and types of airplanes using Lindbergh Field are re-examined and reconciled with currently known facts.

2. That the cost be determined for transferring the operations of big, jet-propelled aircraft from Lindbergh Field


to the existing, City-owned Brown Field, and using Lindbergh Field only for such general aviation and short-haul, commuter services as can be accommodated without exceeding a Community Noise Equivalent Level of sixty-five decibels; and that this cost be compared with the total expenditures under the plan proposed in the draft Final Report.

BE IT FURTHER RESOLVED, that the Council hereby reaffirms previous resolutions and statements of position on Lindbergh Field.

BE IT FURTHER RESOLVED, that the City's representative to the CPO be, and he is hereby directed to act and to vote accordingly.
