

RESOLUTION NO. 218123

WHEREAS, the people of the State of California have enacted the Nejedly-Hart State, Urban and Coastal Park Bond Act of 1976, which provides funds to the State of California and its political subdivisions for acquiring lands and for developing facilities for public recreation and historical purposes; and

WHEREAS, the State Department of Parks and Recreation has been delegated the responsibility for the administration of the program within the state, setting up necessary procedures governing application by local agencies under the program; and

WHEREAS, said procedures established by the State Department of Parks and Recreation require The City of San Diego to certify by resolution the approval of applications prior to submission of said applications to the state; and

WHEREAS, said applications contain assurances that the City must comply with; and

WHEREAS, the City Manager of The City of San Diego will enter into an agreement with the State of California for the acquisition and/or development of the project; and

WHEREAS, the Park and Recreation Department of The City of San Diego has several projects that are designed and have the necessary grant clearances, but remain unfunded; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager be and he is hereby authorized to submit applications as listed on Exhibit A hereto for Nejedly-Hart State, Urban and Coastal Park Bond Act of 1976 state grant assistance.


2. This Council does hereby certify that the City Manager understands the assurances in the application.

3. That The City of San Diego has or will have sufficient funds to operate and maintain the project.

4. That the City Manager has reviewed and understands the General Provisions contained in the sample state/local agreement.

5. That the City Manager be and he is hereby appointed as agent of the City to conduct all negotiations, execute and submit all documents including but not limited to applications, agreements, amendments, payment requests, and so on which may be necessary for the completion of the aforementioned project.
