WHEREAS, the City Manager of The City of San Diego will enter into an agreement with the State of California for the acquisition and/or development of the project; and

WHEREAS, the Park and Recreation Department of The City of San Diego has several projects that are designed and have the necessary grant clearances, but remain unfunded; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager be and he is hereby authorized to submit applications as listed on Exhibit A hereto for Nejedly-Hart State, Urban and Coastal Park Bond Act of 1976 state grant assistance.

- 2. This Council does hereby certify that the City Manager understands the assurances in the application.
- 3. That The City of San Diego has or will have sufficient funds to operate and maintain the project.
- 4. That the City Manager has reviewed and understands the General Provisions contained in the sample state/local agreement.
- 5. That the City Manager be and he is hereby appointed as agent of the City to conduct all negotiations, execute and submit all documents including but not limited to applications, agreements, amendments, payment requests, and so on which may be necessary for the completion of the aforementioned project.
