


RESOLUTION No. 218128 (R-77-1838)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$69,740.90 by Henry L. Foster dba H. L. Foster Construction Company for the IMPROVEMENT OF UNIVERSITY AVENUE FROM FIFTH AVENUE TO SEVENTH AVENUE in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 758020.
2. That the expenditure of \$26,000.00 is hereby authorized out of the Capital Outlay Fund (Fund 245); that the expenditure of \$70,500.00 is hereby authorized out of the Gas Tax Fund (Fund 220) of the City of San Diego solely and exclusively for the purpose of providing funds for the IMPROVEMENT OF UNIVERSITY AVENUE FROM FIFTH AVENUE TO SEVENTH AVENUE in the City of San Diego, and related costs.
