WHEREAS, Section 1930 of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where that street to be vacated has been superseded by relocation; and

WHEREAS, Plumas Street has been relocated by the approval on this date of the dedication of a revised street system within the final map of the subdivision to be known as GENESEE ESTATES; and

WHEREAS, those portions adjoining Plumas Street to be vacated will continue to have access or will be accessible by the streets which have been dedicated with the approval on this date of the subdivision to be known as GENESEE ESTATES;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That Plumas Street adjacent to Lot 11, Lemona Map 684 as more particularly shown on Drawing No. 13945-B on file in the office of the City Clerk as Document No. 758987, which is by this reference incorporated herein and made a part hereof, be, and the same is hereby ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution, with drawings, attested by him under seal, to be recorded in the office of the County Recorder.

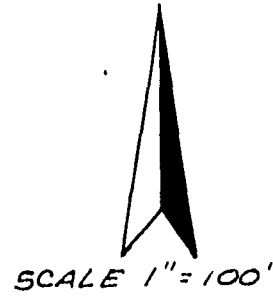

BASIS OF BEARINGS

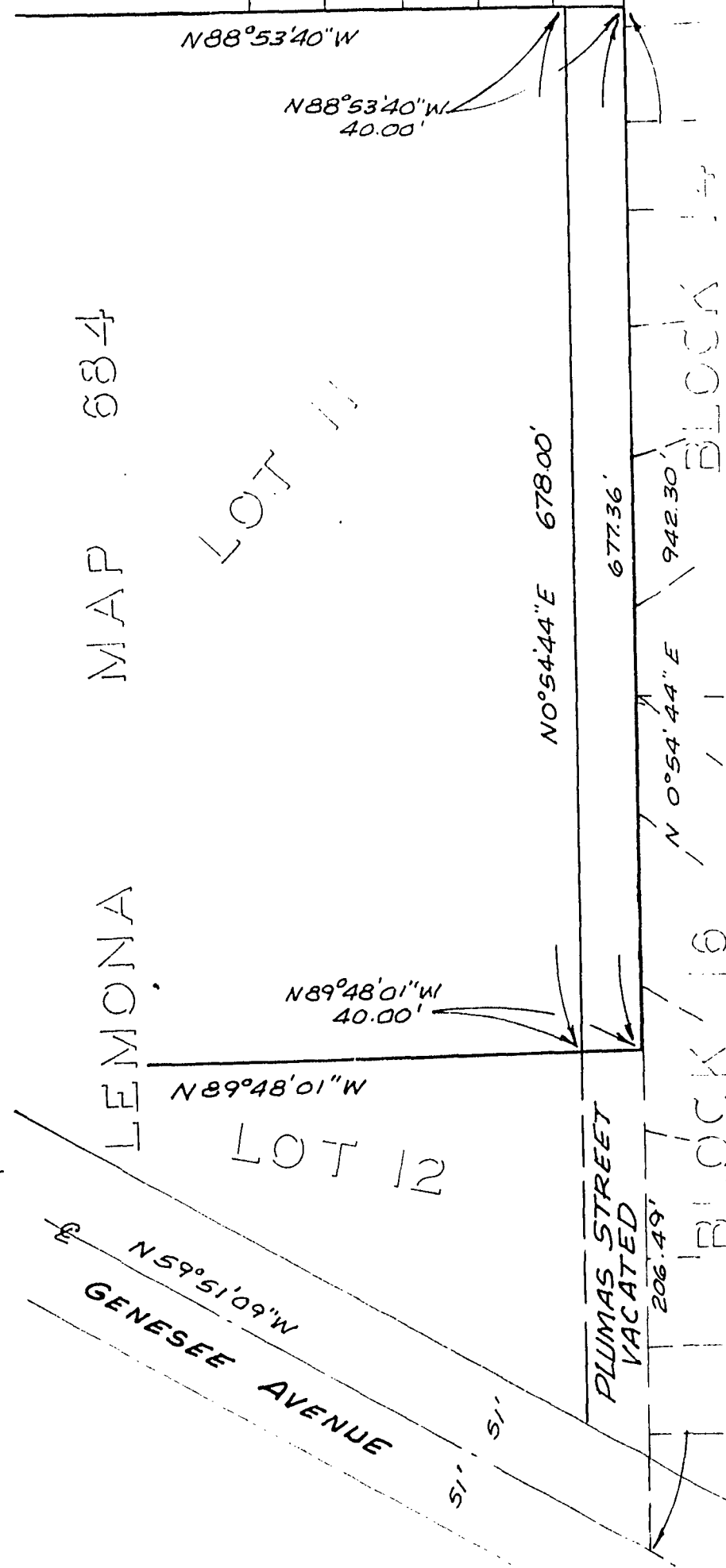
