

RESOLUTION No. 218142 (R-77-1786)

Adopted on APR 13 1977

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Pursuant to authority conferred by and in accordance with the provisions of Section 86.04 of the San Diego Municipal Code, a parking time limit of two hours, between the hours of 8:00 a.m. and 6:00 p.m., Sundays and certain holidays excepted, be and the same is hereby established on the following streets in said City:

Both sides of PEARL STREET, between La Jolla Boulevard and Olivetas Street; and

Both sides of OLIVETAS STREET, between Pearl Street and Marine Street.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and the same is hereby authorized to be made on said streets and that the regulations hereinabove imposed shall become effective upon the installation of such signs.
